The Chair of the Security Council Committee pursuant to resolutions 1267 (1999), 1989 (2011) and 2253 (2015) concerning ISIL (Da'esh), Al-Qaida and associated individuals, groups, undertakings and entities presents his compliments to the Permanent Representatives and Observers to the United Nations and wishes to convey the following:

On **30 March 2017**, the Committee enacted the **amendments** specified with strikethrough/underline in the entry below on its List (the ISIL (Da'esh) and Al-Qaida Sanctions List) of individuals and entities subject to the assets freeze, travel ban and arms embargo set out in paragraph 2 of Security Council resolution 2253 (2015) adopted under Chapter VII of the Charter of the United Nations:

Operates in Java and Sulawesi, Indonesia and also active in Indonesia's eastern provinces. Its former leader is was Abu Wardah, a.k.a. Santoso (deceased not listed).
